After graduating from Harvard University and Harvard Business School, he spent many successful years at four highly distinguished firms—Goldman Sachs, Clayton, Dubilier & Rice, The Blackstone Group, and Silver Point Capital. In 2009, he was selected to serve on the President's Auto Task Force, the group responsible for the overhaul of General Motors and Chrysler. Wilson also serves on the board of Youth, INC, a New York City-based nonprofit focused on introducing private sector expertise to charities focused on disadvantaged youth. (Each affiliated or Subsidiary Corporation, if a separate legal entity has its own limits.) Contributions from LLPs and LLCs are treated as individual contributions. Contributions from foreign nationals are prohibited. An individual residing in the United States who possesses a green card may contribute. Political contributions are not tax deductible.
